## NOTICE TO CREDITORS

NOTICE IS HEREBY GIVEN pursuant to Section 29 of the Trustee Ordinance (Chapter 29, Laws of Hong Kong) that the SPDR® FTSE® Greater China ETF (the “Fund”), a sub-fund of the SPDR® ETFs and the SPDR® ETFs will be terminated together on or around 14 August 2023.

Any persons or creditors who believe they have any interest, claim or entitlement to the property of the Fund (but who have not been contacted about the termination) should send full particulars in writing of his/her interest, claim or entitlement in the property of the Fund to the Trustee of the Fund: State Street Trust (HK) Limited (the “Trustee”) at 68/F, Two International Finance Centre, 8 Finance Street, Central, Hong Kong.

Details must be sent within two months from the date of this Notice. After expiration of the two month period, the Trustee will proceed to distribute the property of the Fund among persons entitled thereto, having regard only to the claims of which the Trustee had notice and shall not as to the property so distributed, be liable to any person of whose claim the Trustee has not had notice (formal or otherwise) at the time of the distribution.

If you have already received correspondence relating to the termination, you do not need to write to the Trustee.
