

It is hereby notified that sealed tenders in quadruplicate are invited for **Contract No. 2313EM22W—Replacement of Traffic Control and Surveillance System of the Lion Rock Tunnel**. The scope of the Works includes dismantling and renovation of existing Traffic Control and Surveillance System, including supply, installation, testing and commissioning of new system and migration of services. The new Traffic Control and Surveillance System shall mainly consist of computerised central control system, traffic control and surveillance field equipment, communication network etc. The civil works include construction and erection of mounting structures for traffic control and surveillance field equipment. The Contract is scheduled to commence in July 2023 for completion in July 2025.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box located in Room 503, 5/F., Low Block, Queensway Government Offices, 66 Queensway, Hong Kong before 12.00 noon on Friday, 5 May 2023. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If Tropical Cyclone Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 5 May 2023, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 5 May 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
