### **Explanatory Note**

This Regulation amends Schedule 2 to the Security and Guarding Services (Licensing) Regulation (Cap. 460 sub. leg. B) (*principal Regulation*) to replace the licence form prescribed for the purposes of section 2(2) of the principal Regulation. The licence form is applicable to a licence issued or renewed under the Security and Guarding Services Ordinance (Cap. 460) for a company to supply individuals to do certain types of security work for another person for reward.

- 2. This Regulation also replaces section 4 of the principal Regulation to provide for the saving arrangements for existing licences.
- 3. This Regulation also makes minor textual amendments to the principal Regulation.
