## **SCHEDULE**

Foreshore and sea-bed affected

Approximately 235 hectares of sea-bed situated to the west of Lamma Island as delineated and shown edged red on a plan, numbered ISM3424, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Dredging of the sea-bed to form sea-bed pits, filling of the sea-bed pits with contaminated sediment and subsequent capping of the sea-bed pits with uncontaminated material to a level not higher than the original sea-bed.
