RESUMPTION OF LAND

This notice was affixed to the above-mentioned land on 18 May 2023. Upon expiration of the notice period at midnight on 18 August 2023, the above-mentioned land shall revert to the Government of the Hong Kong Special Administrative Region. The date of reversion shall be 19 August 2023.
