

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 2514EM22T, 5 Years Term Contract for Provision of Maintenance, Modification and Installation Works for Split Cycle Offset Optimisation Technique (SCOOT) Traffic Control System and Smart Junctions**. The scope of the Works includes maintenance, modification and installation works for the Area Traffic Control (ATC) System of Tuen Mun and Yuen Long District as well as provision of first line maintenance for traffic signals & accessories equipment. The Contract is scheduled to commence in September 2023 for expiry in September 2028.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 503, 5/F, Low Block, The Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 14 July 2023. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If Tropical Cyclone Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 14 July 2023, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 14 July 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. The tenderer shall have completed contract(s) for supply, installation, modification or maintenance of traffic signal controller and audible traffic signal in Hong Kong with an aggregate contract value of not less than HK\$19.77 million completed within the past 5 years counting back from and including the original date set for the close of tender specified in the Government Gazette to tender regardless of any subsequent extension. In the case of a joint venture, only the lead participant or major shareholder is required to meet this experience requirement.
