Tenders are invited for the Provision of Services for Recycling Stations at Eastern, Kwai Tsing, Sai Kung, Sha Tin, Tuen Mun, Wan Chai and Wong Tai Sin District for a period of 31 months and 3 days, 30 months, 30 months and 28 days, 32 months and 20 days, 33 months, 30 months and 28 days, and 30 months respectively effective from early-2024 to mid-2024 or the Date of Tender Acceptance, whichever is the later, subject to and in accordance with the terms and conditions as set out in the Tender Document.

Completed Tender Documents and all accompanying documents must be completed, signed in FIVE identical copies (one original and four copies) and enclosed in a sealed plain envelope marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon (Hong Kong Time) on 28 July, 2023. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon (Hong Kong Time) on 28 July 2023, the tender closing time will be postponed to 12.00 noon (Hong Kong Time) on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon (Hong Kong Time) on 28 July 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
