

## LANDS RESUMPTION ORDINANCE (Chapter 124)

(Notice under section 4)

RESUMPTION OF LAND FOR  
DRAINAGE IMPROVEMENT WORKS AT NORTH DISTRICT—  
SHEK KIU TAU, SHA TAU KOK

To the owners and every person interested or having any right or easement in all those pieces or parcels of land in the New Territories more particularly described below and shown coloured orange on the Resumption Plan No. DNM3864:—

Lots Nos. 1870 RP (Portion), 1871 S.A RP (Portion), 1872 (Portion), 1873 RP (Portion), 1874 (Portion), 1875 RP (Portion), 1876 RP (Portion), 1877 RP (Portion), 1878 RP (Portion), 1879 (Portion), 1883 (Portion), 2036 S.A (Portion), 2036 RP (Portion), 2039 (Portion) and 2040 RP (Portion) all in Demarcation District No. 39.

TAKE NOTICE that the Chief Executive in Council has decided that the above-mentioned land is required for a public purpose, and under powers delegated by the Chief Executive of the Hong Kong Special Administrative Region, I have made an order that the above-mentioned land shall be resumed and revert to the Government of the Hong Kong Special Administrative Region on the expiration of THREE MONTHS from the date of the affixing of this notice to the said land.

This notice was affixed to the above-mentioned land on 10 August 2023. Upon expiration of the notice period at midnight on 10 November 2023, the above-mentioned land shall revert to the Government of the Hong Kong Special Administrative Region. The date of reversion shall be 11 November 2023.
