LANDS RESUMPTION ORDINANCE (Chapter 124)

In exercise of the power conferred on me under section 23(1) of the Lands Resumption Ordinance (Chapter 124) (the Ordinance), I hereby specify the following projects proposed by the Director of Lands (the Authority) for the purposes of section 23(2) of the Ordinance where the boundary of the land proposed to be resumed for the purpose of such projects has been made available to the public (or a section of the public) before 1 September 2023, whether or not the relevant boundary is varied on or after that date:—
