## PROPOSED ROAD WORKS FOR SITE 3 OF THE NEW CENTRAL HARBOUR FRONT

TAKE NOTICE that under powers delegated by the Chief Executive, the Acting Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently sections of the existing carriageway at Lung Wo Road (the Hatched Black Area located on Lung Wo Road), the existing amenity areas at Lung Wo Road (the Hatched Red Areas located on Lung Wo Road) and the existing footpath at Lung Wo Road (the Stippled Black Area located on Lung Wo Road but excluding the Stippled Black Area between the General Post Office and Edinburgh Place) within the limit of works area as shown on Plan No. HKM10138a ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 8953 published on 1 December 2017 and 8 December 2017. The Acting Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that as from 8 September 2023, all public or private rights in, upon, under or over the sections of the existing carriageway at Lung Wo Road (the Hatched Black Area located on Lung Wo Road), the existing amenity areas at Lung Wo Road (the Hatched Red Areas located on Lung Wo Road) and the existing footpath at Lung Wo Road (the Stippled Black Area located on Lung Wo Road but excluding the Stippled Black Area between the General Post Office and Edinburgh Place) to be permanently closed, shall be extinguished.

The works to be carried out in association with this closure mainly involve demolition of sections of the existing carriageway, amenity areas, footpath and lift, construction of a temporary staircase, and other ancillary works.
