**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF TUEN MUN RIVER (EASTERN BANK) GARDEN,
WU KING ROAD GARDEN, AND PARTS OF PUI TO ROAD (SOUTH) REST
GARDEN, TUEN MUN PARK, WU SHAN RECREATION PLAYGROUND AND
TUEN MUN PROMENADE AND ITS ADJACENT FOOTPATHS**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Logistics has, by order made on 15 September 2023 (the ‘Order’), authorized:–

- (I) the temporary closure of Tuen Mun River (Eastern Bank) Garden, as delineated and shown in red on the Plan numbered TMSE/G03/0002/1;
- (II) the temporary closure of Wu King Road Garden, as delineated and shown in yellow on the Plan numbered TMSE/G06/0002/1;
- (III) the temporary closure of part of Pui To Road (South) Rest Garden, as delineated and shown in blue on the Plan numbered TMSE/G02/0002/1;
- (IV) the temporary closure of part of Tuen Mun Park, as delineated and shown in brown on the Plans numbered TMSE/G02/0002/1 and TMSE/G03/0002/1;
- (V) the temporary closure of part of Wu Shan Recreation Playground, as delineated and shown in orange on the Plan numbered TMSE/G05/0002/1;
and
- (VI) the temporary closure of part of Tuen Mun Promenade and its adjacent footpaths, as delineated and shown in green on the Plan numbered TMSE/G06/0002/1,

during the period from 11 October 2023 to 10 October 2024 for the purposes of or incidental to the railway scheme of the Tuen Mun South Extension. A description of the works to be carried out, the areas of Tuen Mun River (Eastern Bank) Garden, Wu King Road Garden, part of Pui To Road (South) Rest Garden, part of Tuen Mun Park, part of Wu Shan Recreation Playground and part of Tuen Mun Promenade and its adjacent footpaths to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered TMSE/G02/0002/1, TMSE/G03/0002/1, TMSE/G05/0002/1 and TMSE/G06/0002/1 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:–

A copy of this notice will be affixed on or near Tuen Mun River (Eastern Bank) Garden, Wu King Road Garden, Pui To Road (South) Rest Garden, Tuen Mun Park, Wu Shan Recreation Playground and Tuen Mun Promenade and its adjacent footpaths affected by the Order on 22 September 2023.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Logistics so as to reach the Secretary for Transport and Logistics before the expiration of one year from the closure of the relevant part or parts of Tuen Mun River (Eastern Bank) Garden, Wu King Road Garden, Pui To Road (South) Rest Garden, Tuen Mun Park, Wu Shan Recreation Playground and Tuen Mun Promenade and its adjacent footpaths or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Tuen Mun River (Eastern Bank) Garden, Wu King Road Garden, Pui To Road (South) Rest Garden, Tuen Mun Park, Wu Shan Recreation Playground and Tuen Mun Promenade and its adjacent footpaths affected by the Order. Claims can be submitted via one of the following means:–

- (1) by post or by hand to the Transport and Logistics Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8:00 a.m. and 7:00 p.m. from Monday to Friday (except public holidays);

Notice is hereby given that further closure of the same part or parts of Tuen Mun River (Eastern Bank) Garden, Wu King Road Garden, Pui To Road (South) Rest Garden, Tuen Mun Park, Wu Shan Recreation Playground and Tuen Mun Promenade and its adjacent footpaths or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
