PROPOSED ROAD WORKS AT KENNEDY ROAD, QUEEN'S ROAD EAST AND SHIP STREET, WAN CHAI, HONG KONG

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths and safety islands within the limit of works area as shown on Plans Nos. KR/001 and QREKR/002 ('the Plans') and described in the scheme annexed thereto, and as amended by Amendment Plans Nos. KR/001A, QREKR/002A and LEGEND/001 ('the Amendment Plans') and described in the amendment scheme annexed thereto. The Plans and scheme were referred to in G.N. 2152 published on 9 April 2009 and 17 April 2009. The Amendment Plans and amendment scheme were referred to in G.N. 4417 published on 12 July 2019 and 19 July 2019. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 1 October 2023 to 31 December 2023, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths and safety islands to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve widening and realignment of sections of the existing carriageways and footpaths at Kennedy Road and Queen's Road East with associated road modification works; construction of a flyover, an underpass and an elevated walkway at Kennedy Road; construction of a covered footbridge with associated lifts and staircases at the junction of Queen's Road East and Kennedy Road; and ancillary works.
