PROPOSED ROAD WORKS FOR THE FUTURE PROPERTY DEVELOPMENT ON MA ON SHAN LINE TAI WAI STATION

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways and footpaths within the limit of works area as shown on Plan No. RDM1126 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 7672 published on 10 December 2010 and 17 December 2010. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 1 October 2023 to 30 September 2024, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure is mainly to facilitate the future property development at the Ma On Shan Line Tai Wai Station including modification and extension of the existing covered footbridge; modification of parts of the existing public transport interchange and the existing bicycle parkings; construction of covered footbridges and provision of public access.
