TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently sections of the existing carriageway and footpaths; and to close temporarily sections of the existing carriageways, footpaths, amenity areas and traffic islands within the limit of works area as shown on Plan No. TP10/GAZ/C/DSB-01 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 5862 published on 24 September 2021 and 30 September 2021. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that as from 20 October 2023, all public or private rights in, upon, under or over the sections of the existing carriageway and footpaths to be permanently closed, shall be extinguished; and from 20 October 2023 to 19 October 2024, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, amenity areas and traffic islands to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve construction of a carriageway, footpath, track, traffic islands and vehicular run-in/run-out, as well as other ancillary works.
