TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageway, footpath, pedestrian crossing and cycle track within the limit of works area as shown on Plan No. HWDST162A-GZ0001 ('the Plan') and described in the scheme annexed thereto. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 2 November 2023 to 1 November 2024, all public or private rights in, upon, under or over the sections of the existing carriageway, footpath, pedestrian crossing and cycle track to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a walkway cover along Lok King Street and other ancillary works.
