Foreshore and sea-bed affected

Approximately 1.07 hectares of foreshore and sea-bed situated near Ma Nam Wat Village as delineated and shown edged red on a plan, numbered SKM10200, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Works include modification and extension of the existing Ma Nam Wat Pier and provision of a temporary pier during the construction stage. The proposed pier will be composed of a suspended deck founded on piles, a gangway and a floating platform held in position by piles, covering an area of approximately 380 square metres above the sea
