TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under sections 17(1)(a) and 17(1)(b) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths and amenity areas within the limit of works area as shown on Plans Nos. CEDD/GZ7785/002, CEDD/GZ7785/003 and CEDD/GZ7785/006 and described in the scheme annexed thereto; and to temporarily reclaim (not for the purpose of forming land) part of the Government foreshore within the limit of works area as shown on Plan No. ČEDD/ GZ7785/003 and described in the scheme annexed thereto for modification of the existing seawall for the construction of the temporary barging point and reinstatement of the said seawall as shown on Plan No. CEDD/GZ7785/003. The Plans Nos. CEDD/GZ7785/002. CEDD/ GZ7785/003 and CEDD/GZ7785/006 and scheme were referred to in G.N. 5102 published on 5 September 2014 and 12 September 2014. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 14 November 2023 to 13 November 2024, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths and amenity areas to be temporarily closed, part of the Government foreshore to be temporarily reclaimed, and part of the Government foreshore and sea-bed in the temporary barge mooring area within the limit of works area as shown on Plan No. CEDD/ GZ7785/003 and described in the scheme annexed thereto, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a dual two-lane trunk road (of which part is in the form of a tunnel) between the South Apron of the former Kai Tak Airport and Cha Kwo Ling; construction of sections of at grade carriageways, depressed carriageways, central reserves and amenity areas; and other ancillary works as well as the construction of a tunnel portal, traffic facilities for tunnel operation, a ventilation building and a temporary barging point.

The works to be carried out in association with this reclamation mainly involve modification of the existing seawall for the construction of the temporary barging point and reinstatement of the said seawall.
