PWP ITEM NO. 7702CL (PART) KAI TAK DEVELOPMENT— STAGE 5 INFRASTRUCTURE AT THE FORMER RUNWAY AND SOUTH APRON

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, footbridge, amenity areas and central medians/traffic islands within the limit of works area as shown on Plan No. CEDD/GZ702/001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 5996 published on 18 August 2017 and 25 August 2017. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 14 November 2023 to 13 November 2024, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, footbridge, amenity areas and central medians/traffic islands to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of Road L10 (Southern section) and Road L18 with associated footpaths; construction of Road S20 with associated footpath; extension of Kai Hing Road and associated footpath; construction of a landscaped elevated walkway with associated lifts and staircase; construction of amenity areas, central medians/traffic islands and pedestrian crossings, as well as other ancillary works.
