

FORESHORE AND SEA-BED (RECLAMATIONS) ORDINANCE (Chapter 127)

(Notice of authorization under section 9)

CONSTRUCTION OF PUBLIC LANDING FACILITIES AT
ABERDEEN SOUTH TYPHOON SHELTER

It is hereby notified that the undertaking in relation to the foreshore and sea-bed described in the Schedule below was authorized under sections 8(1)(c) and 8(2) by the Chief Executive in Council on 7 November 2023.

Any person who considers that he has an interest, right or easement in or over such foreshore and sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the Gazette, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

SCHEDULE

Foreshore and sea-bed affected

Reduction from approximately 0.44 hectares to approximately 0.32 hectares of foreshore and sea-bed situated in Aberdeen South Typhoon Shelter near Ap Lei Chau Praya Road as delineated and shown edged red and purple respectively on a modification plan, numbered HKM11091a, deposited in the Land Registry.

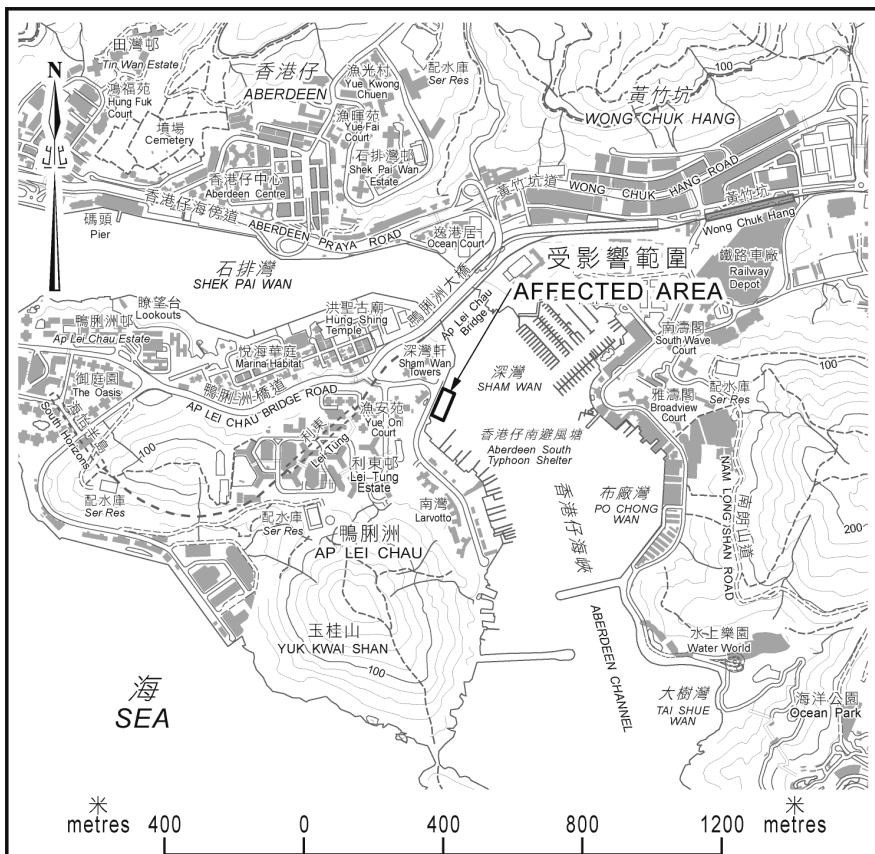
Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Construction of two sets of public landing facilities at Aberdeen South Typhoon Shelter near Ap Lei Chau Praya Road. The proposed public landing facilities will include two sets of public landing steps. It will cover an area of approximately 118 square metres above the sea.

The area of foreshore and sea-bed affected is shown on the plan on the next page for identification purposes only. The area is more particularly shown on the plan numbered HKM11091a above referred to.


Personal Information Collection Statement
