TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways and footpaths within the limit of works area as shown on Plan No. KM10518 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 5385 published on 3 September 2021 and 10 September 2021. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 6 February 2024 to 5 February 2025, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the conversion of a section of the existing footpath into carriageway; and other ancillary works.
