## (Notice under section 18)

## ROAD WORKS AT WANG HOI ROAD, WANG MAU STREET, SHEUNG YEE ROAD, WANG YUEN STREET AND WANG TAI ROAD

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently sections of the existing carriageway, footpaths, lay-bys, traffic island and pedestrian crossings at Wang Hoi Road; and close temporarily sections of the existing carriageways, footpaths, traffic islands, pedestrian crossings and verges at Wang Hoi Road, Wang Mau Street, Wang Yuen Street, Wai Yip Street and Sheung Yee Road within the limit of works area as shown on Plan No. KT30/GAZ/C/DSB-01 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 1607 published on 1 April 2022 and 8 April 2022. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that as from 15 February 2024, all public or private rights in, upon, under or over the sections of the existing carriageway, footpaths, lay-bys, traffic island and pedestrian crossings at Wang Hoi Road to be permanently closed, shall be extinguished; and from 15 February 2024 to 14 February 2025, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, traffic islands, pedestrian crossings and verges at Wang Hoi Road, Wang Mau Street, Wang Yuen Street, Wai Yip Street and Sheung Yee Road to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a footpath at Wang Mau Street, the conversion of sections of the existing carriageway, traffic island and pedestrian crossings at the junction of Wang Hoi Road and Sheung Yee Road into a footpath, the conversion of a section of the existing lay-by at Wang Hoi Road into a carriageway, the demolition of a section of the existing carriageway and sections of the existing lay-bys and footpaths at Wang Hoi Road and other ancillary works.

This notice will be affixed on or near the affected carriageways, footpaths, traffic islands, pedestrian crossings, lay-bys and verges on 9 February 2024.

Any person having a compensatable interest under the Ordinance may serve upon the Secretary for Transport and Logistics a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
