TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, amenity areas and central medians/traffic islands within the limit of works area as shown on Plan No. 5193437-GAZ-1001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 3343 published on 4 June 2021 and 11 June 2021. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 3 March 2024 to 2 March 2025, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, amenity areas and central medians/traffic islands to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve modification of Hoi Yuen Road/Wai Yip Street roundabout into a signal controlled junction; construction of proposed Roads L1 and L2 with associated footpaths and central medians/traffic islands and construction of a covered footbridge with associated staircase and lifts across Wai Yip Street from Hoi Yuen Road to Kwun Tong Action Area; and other ancillary works.
