### **Explanatory Note**

The Road Traffic (Traffic Control) (Designation of Prohibited and Restricted Zones) Notice (Cap. 374 sub. leg. U) (*principal Notice*) sets out in its Schedules certain prohibited zones and restricted zones in the Hong Kong International Airport. Specifically speaking—

- (a) Schedule 1 to the principal Notice sets out the prohibited zones in which the driving of certain motor vehicles is prohibited;
- (b) Part 1 of Schedule 2 to the principal Notice sets out the restricted zones in which drivers of certain motor vehicles are prohibited from picking up or setting down passengers or from loading or unloading goods; and
- (c) Part 2 of Schedule 2 to the principal Notice sets out the restricted zones in which drivers of certain motor vehicles are prohibited from doing certain acts specified in that Part.
- 2. This Notice amends Schedule 1 to the principal Notice to—
  - (a) vary the designation of certain areas as prohibited zones (section 4(1), (4), (5) and (7) to (12));
  - (b) remove certain areas from the list of prohibited zones (section 4(2)); and
  - (c) designate certain areas as prohibited zones (section 4(3), (6), (13) and (14)).
- 3. This Notice also amends Part 1 of Schedule 2 to the principal Notice to—

- (a) vary the designation of certain areas as restricted zones (section 5(1), (6) and (8));
- (b) remove certain areas from the list of restricted zones (section 5(2)); and
- (c) designate certain areas as restricted zones (section 5(3) to (5), (7) and (9)).
- 4. This Notice also amends Part 2 of Schedule 2 to the principal Notice to remove certain areas from the list of restricted zones (section 5(10)).
